


The procuring entity shall be allowed to make adjustments in the units/volume to be delivered per type of product to conform to the remaining amount in the total contract price.
3. The supplier shall be responsible to dispense fuel to **Provincial General Services Office** vehicles only and ensure that issued fuel will not exceed PO allocation.

8. The supplier shall be located within **1** radius from the requisitioning office.



9. No advance withdrawal is allowed prior to the approval of the Purchase Order.





