MANGKAY FMR WITH BRIDGE under MIADP Subproject number: MIADP-IN-RO11-DDN-AD-TAL-FRD-0010 hereinafter called the "Works", and the Entity has accepted the bid for ONE HUNDRED THIRTY-FIVE MILLION SIX HUNDRED EIGHTY-FOUR THOUSAND TWO HUNDRED FIFTY-NINE PESOS AND FIFTY-EIGHT CENTAVOS (PHP 135,684,259.58) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.
